On February 17, 2016, the Court granted Cuyahoga County Prosecutor Timothy J. McGinty's Motion for the appointment of Mike DeWine, Ohio Attorney General, and any assistant attorney general in his office that he deems necessary, as Special Prosecuting Attorney in the investigation of the above captioned matter.

On March 22, 2016, the Court granted the State's Motion for a Special Master, filed by the Special Prosecutor. In the Court's Order it was noted that the Special Master would be appointed by a separate journal entry.

Wherefore, the Court hereby appoints Retired Judge Thomas J. Pokorny as its Special Master in this matter to review the investigation file(s) for any "Garrity" material and any material derivative of it. Judge Thomas J. Pokorny, after his review, will provide the "Garrity" protected materials, if any, and a copy of the files that are not implicated by "Garrity" to this Court for an *in camera* inspection. During its *in camera* inspection, the Court may inquire of Special Master Judge Thomas J. Pokorny. During the pendency of this matter, the Special Master shall have no contact with the Ohio Attorney General's Office or the Cuyahoga County Prosecutor's Office.

The Cuyahoga County Prosecutor's Office and the Cuyahoga County Sheriff's Office are hereby ordered to forward, under seal, the entire contents of its investigation file(s) and any other relevant materials/documents to Common Pleas Court Administrator Gregory M. Popovich, who shall arrange for hand delivery of these items to Special Master Judge Thomas J. Pokorny.

The Cuyahoga County Prosecutor's Office and the Cuyahoga County Sheriff's Department are also ordered to advise this Court by April 18, 2016, of any other relevant agencies, if any, which conducted an investigation in this matter so that the necessary steps can be taken to secure the investigation file(s) and other relevant materials/documents from them.

Special Master Judge Thomas J. Pokorny will advise the Court Administrator upon completion of his review of the investigation file(s) and related materials/documents. The Court Administrator shall make arrangements for the hand delivery, under seal, of these items to this Court for its *in camera* inspection.

Special Master Judge Thomas J. Pokorny shall be compensated for his services in this matter at the same rate of pay as a Visiting Judge in the State of Ohio.
